## CITY COUNCIL MEETING MINUTES Tuesday, June 11, 2024 City Hall 23170 CR 4117, Frankston, TX

Minutes of the City of Berryville June 11, 2024, City Council Meeting. Members present: Mayor Susan Morgan, Mayor Pro Tem Gayla Leary, Councilwoman Bobbie Evans, Councilman Clinton Lax, Councilman Lucas Wagenaar and Councilman Gene Fagelson.

1. Call the meeting to order and have a Moment of Silence.
